## Eligibility

### Under 30

This membership is only available for individuals who are under the age of thirty and will continue to be under the age of thirty for the duration of their annual membership.

### Individual

This membership is available to any individual.

### Institutional

This membership is only available for academic institutions and not-for-profit and it is not available for for-profit or commercial organisations. The membership belongs to an institution or organisation. 1 institutional membership can register up to 3 representatives who belong to that institution. The representatives registered may be changed from time-to-time.

### Supporting Member

This membership is available for any organisation including academic institutions and for-profit commercial businesses. The membership belongs to an institution or organisation. 1 Supporting membership can register up to 5 representatives who belong to that institution. The representatives registered may be changed from time-to-time.

## Explanation of benefits

- Prices are for 1 year of membership.
- Each membership carries 1 voting right only, at the AGM. Institutional and support memberships do not carry more than 1 vote at AGMs even if they allow 3 or more individual members to register.

The board will approve profiles which conform to the individual trainer directory guidelines. Guidelines: The profile word limit is 250 words. The profile must be written in first person singular 'I' or third person singular 'he/she' and not in first person 'we'. The profile must detail the individual's experience and must not be interpreted as promoting an external organisation. ## Listing in public EULETA Directory of Organisations

Institutions and Supporting Members can submit a profile of their institution or organisation to the board be listed in our public EULETA directory of organisations. The board will approve profiles which conform to the organisation trainer directory guidelines. Guidelines: The profile word limit is 500 words. The profile must be written in first person plural 'we' or third person singular or plural 'it/they'. The profile can detail and promote the organisation's activities. Profiles must be submitted to [secretary@euleta.org](mailto:secretary@euleta.org).

## Distribute your promotional material at EULETA events

Institutional and Supporting Members may present promotional material at EULETA conferences and workshops such as placing flyers on the welcome table and putting up a poster near the welcome table or event room, subject to the guidelines. Guidelines: Institutional and Supporting Members wishing to present promotional material must submit a request to the board detailing what promotional material they wish to present at a forthcoming EULETA event, which will be approved at the board's discretion. Institutional members are not permitted to promote any for-profit activities and Supporting Members may promote for-profit activities. ## Place EULETA logo on your website

Supporting Members may place the EULETA logo on their website with an explanation such as "We are a supporting member of EULETA the European Legal English Teachers' Association". You may not use the words 'partner' and must not state that your activities are endorsed by EULETA.
